The underlying issue of independence soon emerged and<br>the conflict escalated between the government of PNG and the native islanders, in turn<br>spearheaded by the Bougainville Revolutionary Army (BRA). Until fighting ended in 1998,<br>an estimated 20,000 died in the conflict.
