### **Nepalese Insurgency (1996 - 2006)**

Inspired by the Maoist insurgency in Peru in the early 1990s, the Communist Party of Nepal (Maoist) – CPN(M) – declared war on the Nepalese government in February 1996. A key demand was the transformation of Nepal from a monarchy into a ‘People’s Republic’. Following a pronounced Maoist military strategy, the CPN(M) focused their insurgency on the rural areas. They gained significantly in strength and it took heavy international military support to stabilize the Nepalese government in 2002. After public protests escalated in Kathmandu in 2004, the Nepalese King Gyanendra took authoritarian control over the government. In the cities, a strong popular movement for democracy emerged, forcing the government into fast progressing peace negotiations in 2006 that concluded with the signing of a Comprehensive Peace Accord on 21 November 2006.

### Local agreement properties

<b>Process type</b>	Formal structured process
<b>Rationale</b>	A Dialogue team was set up by the government comprising of seven political parties, and led by Mr Ram Chandra Poudel, Minister for Peace and Reconstruction to pursue dialogue and find solution to various movements after the CPA. The team also pursued multiple rounds of talks with the Madhesi Janadhikar Forum to find solution to their movement.
<b>Is there a documented link to a national peace process?</b>	Yes
<b>Link to national process: articulated rationale</b>	The movement of this group started arguing that the Interim Constitution, while stated of 'state restructuring' did not categorically commit to federalism. This agreement, accordingly, was based on greater guarantees in the Constitution on federalism, recognition to Madheshi languages, proportional representation etc. It needs to be mentioned that though their demands surfaced after the CPA, this group was formed in the 1990s, and focused on the issues of Terai/ Madhesh or the Southern plains in Nepal.
