

PEACE DIALOGUES TABLE BETWEEN THE NATIONAL GOVERNMENT OF THE REPUBLIC OF COLOMBIA AND THE CENTRAL GENERAL STAFF OF THE FARC-EP

SPECIAL AGREEMENT ON TERRITORIAL TRANSFORMATIONS IN CAQUETÁ, META AND GUAVIARE

The National Government and the Central General Staff of the FARC-EP ratify their interest in the protection of strategic ecosystems and their connectivities, which is why they express their decision to work for the containment of deforestation, sustainable development, and the guarantee of the rights of the populations that inhabit in the protected areas and zones of law 2 of 1959.

We, the parties, are aware of the right of the communities to the agreement of plans for socio-environmental development of a sustainable nature, which requires a methodology of the Peace Dialogues Table that contemplates the participation of the grassroots organisations of the territory, with adequate time and commitments, that provides clarity on the right to land and on the sustainability of the plans that are built on the ground, within the framework of the agreements and protocols established by the parties.

This special agreement will be developed as a component of sustainable development, harmonised with plans for environmental management at national, regional, departmental, municipal and local level, which allows for the protection of both the biodiversity, its basins, soils and subsoils, and also guarantees human beings, communities and peoples, as subjects of rights (economic, social, cultural and environmental) and special protection, as well as guaranteeing their permanence as part of the cultural, social and economic heritage of the territory.

The above requires, inter alia:

- Identify peasant economy projects in areas of the departments: Guaviare, Meta and Caquetá. Organise dialogue with interested families and communities.
- Participatory criteria, with autonomy, pluralism, constructive relations with institutions and those in charge of plans and projects in government entities.
- Form a joint commission for the processes
- Programme of meetings and visits
- Route of work

A. IMMEDIATE ACTIONS

1. Integral experience in Yará: proposals for land formalisation in Yará and pilot plans for housing, electricity, etc. Experience of sustainable livestock farming with genetic improvement and stabilisation or reconversion in Yará, Meta and Guaviare (pilot plans in these departments). Promote a proposal for a cold storage and pasteurisation plant in San Vicente del Caguán. Establish reference coordinates and verify the number of hectares for land formalisation and coca substitution with the agrarian bank's

credit programme. On this point, the agrarian judges can provide a solution. Evaluate the possibility of a guarantee for the commercialisation of harvests (the table should be directed so that the AMNA buys what the farmers produce), farmers' markets as a mechanism to be able to commercialise and avoid intermediaries, agreement on fixed prices for both supplies and farmers' products. Biodigesters and pigsties.

2. Support the efforts of indigenous communities, which process coca, cannabis and give alternative use, to develop a meeting with the Ministry of Justice, DIAN, and Invima in order to strengthen these economic initiatives.

To have an explanation of the Fund for Life and Biodiversity, credit and promotion policies. Seek diagnoses and projects for the viability of productive reconversion from academic and scientific entities; support the genetic banks that currently exist. Advance in contracting with JACs and associations within the existing regulatory frameworks. Among the areas for forest development are, in Caquetá: Solano, Ilusión, El Camuya, Ciudad Yari, Cuemaní, Bajo Caguán, and the area between the left bank of the Caguán river and the Tunia river. In Guaviare: Agua Bonita, Los Puertos, Charras, Nueva Ilusión, Miraflores, Nueva York. Chuapal - Manavires, , Angolet, In Meta: Mapirián, ZRC Güejar - Cafre de Puerto Rico, Vista Hermosa, others to be added.

Contracting with Community Action Boards for the construction of secondary and tertiary roads. Specify the legally established routes. Evaluate the situation of land for projects in relation to the various categories of Law 2a. Rezoning with sustainable use zones for national natural parks with people and peasant housing for national natural parks (article 29 of the National Development Plan); Legislative review and review of the National Parks System. Watershed management.

- Review the status of roads for territorial plans and those associated with deforestation and illegal activities. Government response on the Marginal de la Selva is requested.
- Define methodology to address land and rural reform proposals and immediate land access initiatives related to halting deforestation. Includes zoning, roads, clean electrification.
- Work on a plan of immediate and other medium and long term actions. Importance of a CONPES.
- National and international funding possibilities. Creation of the necessary funds and sources.
- Creation of a bank of projects.
- Runways: civil aeronautics. A request must be made to formalise the runway for safe operation.
