This agreement is between Dinka Malual and Luo in Northern Bahr el Ghazal State of the Republic of South Sudan and Rezeigat of Eastern Darfur of the Republic of Sudan as:

The Dinka Malual, Luo and Rezeigat delegates to the 2022 Pre-Migration Peace Conference met in Northern Bahr El Ghazal State for five days from June 7th – June 11th, 2022, having reviewed and deliberated over 2021 Pre-Migration resolutions and recommendations, agreed on the following resolutions and recommendations:

Resolutions of Dinka Malual

1. Dinka Malual delegates agreed to form a committee to mediate the internal conflict between Rezeigat community caused by the death of Mahamoud Sadig
2. Dinka Malual delegates validated Northern Bahr el Ghazal State Local Policy on Seasonal Cattle Migration
3. Dinka Malual delegates restructured its Joint Border Peace Committee and joint chief courts
4. Structuring of Dinka High Level Committee comprise of 11 paramount chiefs from migration corridors / routes
5. Continuation of peace conferences between Dinka Malual and Rezeigat
6. Dinka Malual delegates endorsed previous resolutions and recommendations of 2021 peace agreement between Rezeigat and Dinka Malual

Recommendations of Dinka Malual and Rezeigat

1. Dinka Malual delegates recommended that the replacement of Mahamoud Sadig should be from immediate family members in order to comfort and console the aggrieving family
2. Dinka Malual peace committees agreed to make generous contributions to support the family of late Mahamoud Sadig
3. Dinka Malual delegates deliberated and recommended that the NGOs and government counterparts should continue to support the annual pre-migration and post migration peace conferences so that Mahamoud Sadig's dream of peaceful co-existence between Dinka Malual and Rezeigat can still be alive
4. Dinka Malual delegates requested peace partners to build peace center in name of Mahmoud Sadig to honor him for his great contribution to keep peace between Dinka Malual and Rezeigat
5. Rezeigat delegate requested the government of Northern Bahr el Ghazal state to harmonize and reduce taxes on traders
6. Migration fees and work permit should be reviewed and made affordable for traders from Sudan
7. The delegate requested the government of Sudan, South Sudan and peace partners to construct the road Northern Bahr el Ghazal state to Eastern DarFur state to boost trade
8. Rezeigat delegate requested the government of Northern Bahr el Ghazal state to allow the export of small goods to Sudan
9. Rezeigat pastoralists requested the government of Northern Bahr el Ghazal state to reduce development taxes
