## TANA I DECLARATION

POKOMO AND ABDALLA COMMUNITIES RECONCILIATION PROCESS

27<sup>TH</sup> APRIL, 2016

#### **PREAMBLE**

**FOLLOWING** a series of meetings with the county administration and elders from the Tana River and Abdalla communities of Tana River and Garissa Counties from the  $25^{th}$  to  $27^{th}$  April, 2016;

**WE**, the county and sub-county security teams, elders and representatives of peace committees from Ijara and Galole sub-counties on the 27<sup>th</sup> April, 2016 under the guidance of the National Cohesion and Integration Commission Commissioners;

**COGNIZANT** of the impact of the farmer-pastoralist conflict; mistrust and negative perceptions between communities residing in Ijara and Galole sub-counties; boundary and land related issues, insecurity and underdevelopment;

 $\boldsymbol{DESIROUS}$  of the need to promote peace and security in the sub counties and the larger Counties;

**APPLAUDING** the efforts that have been made so far to ensure that peace and security prevails;

AGREE as follows;

#### I. Farmer-Pastoralist Conflict

- 1. THAT all communities regardless of their origin access the Tana River as access to water is a right enshrined in the Constitution
- 2. THAT access to the water resource should not be at the expense of other communities' livelihoods
- 3. THAT compensation to the livelihoods of both the farmer and pastoralist communities should be done in case of any losses/destruction. The aggressor should take full responsibility in compensating the aggrieved parties
- 4. THAT all MALKAS/water corridors should be identified and demarcated

- THAT both county governments of Tana River and Garissa should initiate and fast track the process of passing by-laws that will designate and demarcate MALKAS/water corridors
- 6. THAT farmers should refrain from encroaching the designated MALKAS/water corridors
- 7. THAT both County governments should explore the possibilities of constructing/harnessing additional watering points
- 8. THAT pastoralists should graze their livestock only on designated areas
- 9. THAT grazing committees and relevant traditional governance structures should always be involved in resource use, sharing and management as well as in dispute resolution.
- 10. THAT farmers and pastoralists that have entered into grazing agreements should honor the agreements so established
- 11. THAT both parties must respect the rule of law and report any breach to the authorities
- 12. THAT all parties shall embrace dialogue and traditional dispute resolution mechanisms.
- 13. THAT all animals including donkeys should not be left unattended while grazing

### II. Boundary and Land Related Issues

- 1. THAT county boundaries be respected by all parties
- 2. THAT those using boundary issues as an excuse to divide Kenyans will be prosecuted and face the full force of the law
- 3. THAT both communities should live in their areas peacefully and feel free to move across the boundary

# III. Enhancement of Peaceful Co-existence and Harmonious Living

- 1. THAT we forgive each other for wrongs done in the past without conditions whatsoever, and forge ahead in unity.
- 2. THAT all communities together with their leaders should respect every individual and property

- THAT all actors work together to end hostilities and conflicts along the common border of our counties and conduct continuous community dialogue in order to address issues of mutual interest without resorting to violence
- 4. THAT the county governments of Garissa and Tana River enhance and strengthen the infrastructure for peace in the counties including and not limited to funding of peace building and reconciliation activities in their respective counties.
- 5. THAT with the support of other peace and reconciliation stakeholders conduct more peace meetings at the grassroots level
- 6. THAT past community traditional dispute resolution mechanisms be revived, strengthened and enhanced
- 7. THAT we strengthen and enhance community interaction through joint inter cultural activities, exchange visits, sporting events, intermarriages and business ventures e.g. through establishment of common markets along the border
- 8. THAT peace champions be recognized

#### IV. Good Leadership and Governance

- THAT both communities and their leaders should desist from using demeaning and derogatory language against one another
- 2. THAT politicians/individuals be closely monitored for hate speech and incitement and subsequently charged for the same in a court of law
- 3. THAT the NCIC strengthens its efforts in monitoring and enforcing hate speech and incitement offences

#### V. Security

- 1. THAT community members assist the security officers by volunteering and sharing information on criminal activities
- 2. THAT anyone who provides potentially sensitive/risky information shall be provided with protection in accordance with the Witness Protection Act
- 3. THAT all foreigners and immigrants should report to the respective authorities including chiefs, elders, nyumba kumi committees amongst others
- 4. THAT the police carry out thorough investigations, arrest and prosecute the criminals according to the laws of the land and all ongoing police investigations should proceed to its logical conclusions

- 5. THAT law enforcement agents observe the Public Officer Ethics Act while carrying out their duties.
- 6. THAT public officers from both Tana River and Garissa that do not effectively discharge their duties should be disciplined
- 7. THAT National Police Reservists from either County shall work within their assigned areas and only move out of their respective assigned areas with the authority of their superiors
- 8. THAT security agents be proactive in responding to conflicts through intelligent policing
- 9. THAT suspects/criminals take individual responsibility for the crimes they had committed and not hide under their respective communities.
- 10. THAT elders, representatives of peace committees among other actors counsel their young men and women to counter the resurgence/burgeoning of illegal militia groups
- 11. THAT elders and identified community actors/committees shall assist in pushing forward implementation of resolutions from past meetings with their MPs and Governors
- 12. THAT this agreement binds all parties involved in this conflict and will apply in resolving conflicts affecting other communities within the region

This agreement has been entered willingly and freely by all parties without coercion from any quarter.
